Payment and Registration: By signing and returning the registration form included, you are agreeing to pay all fees listed by the date noted. Sharing of Exhibit Space is not allowed unless approval is requested and approved by Lodi Comic Con. Any requests of this nature must be made at the time of registration.

You also agree to the following:

- All persons in your Booth (Tailgate Area) **MUST** wear a mask that covers the nose and mouth at all times.
- You will provide hand sanitizer at your Booth (Tailgate Area) for any attendee and anyone working your booth.
- You will stay inside the boundaries marked off for your Booth (Tailgate Area).
- You will be parked and ready for attendees by 10:45am, there will be no admittance after 10:45am.

California Seller's Permit: As noted on the registration form, a valid **California Seller's Permit Number** is required to sell any merchandise at your exhibition space.
