TERMS AND CONDITIONS FOR EXHIBITORS

Payment and Registration: By signing and returning the registration form included, you are agreeing to pay all fees listed by the date noted. Sharing of Exhibit Space is not allowed unless approval is requested and approved by Lodi Comic Con. Any requests of this nature must be made at the time of registration.

You also agree to the following:

- All persons in your Booth (or Tailgate Area) are RECOMMENDED to be vaccinated or have a negative COVID test taken not more than 3 days before June 27 or an antigen test taken not more than 1 day before the event. (subject to County and State changes)
- All UNVACCINATED persons in your Booth (or Tailgate Area) MUST wear a mask that covers the nose and mouth at all times.
- It is recommended that ALL persons in your Booth (or Tailgate Area) wear a mask that covers the nose and mouth at all times.
- It is recommended that you have Hand Sanitizer at your Booth (or Tailgate Area) for any attendee and anyone working your booth.
- You will stay inside the boundaries marked off for your Booth (Tailgate Area or indoor areas).
- You will be parked and/or ready for attendees by 10:30am, there will be no admittance for vehicles after 10:30am.

California Seller's Permit: As noted on the registration form, a valid **California Seller's Permit Number** is required to sell any merchandise at your exhibition space. Adult Material: All exhibitors must agree not to sell or distribute adult materials to minors. All materials with "Adult" content must be kept behind your table and is to not be handled by any minors. No display of any covers depicting nudity will be allowed. No adult videos or photos of any kind are allowed to be sold.

Refund Policy: Refunds will be allowed for the full rate if requested by June 1st. Any request for cancellation after June 1st, refunds will be subject to the discretion of Lodi Comic Con, but not guaranteed.
